
The first half of 2012 was a record first half year for company registrations in Edinburgh when compared to any half year in history.

In the first half of 2012 a total of 2,769 companies were formed in Edinburgh. This figure is 18.2% higher than last year, which compares well to the UK wide figure of 10.7%.


Q2 2012 saw a new record in company registrations in Edinburgh when compared to any previous Q2.





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)





net growth by quarter











director age by half year






director age by quarter

director gender by half year


