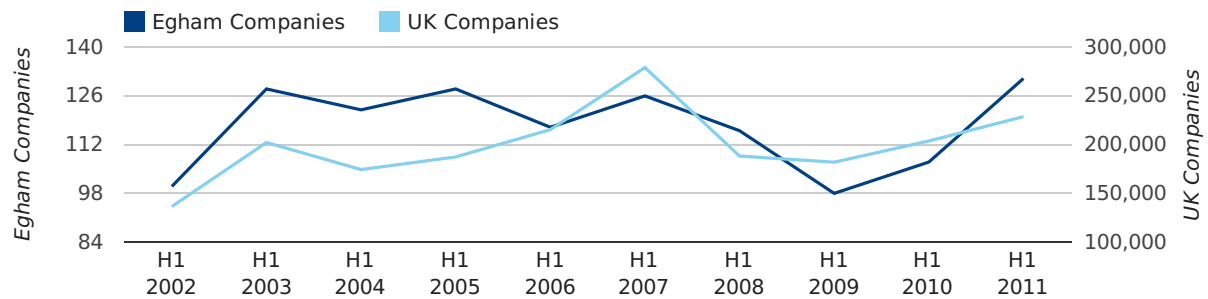
The first half of 2011 saw a new record in company registrations in Egham when compared to any previous first half year.

In the first half of 2011 a total of 131 companies were formed in Egham. This figure is 22.4% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Egham occurred in 2011 when a total of 131 were formed.

new companies by half year



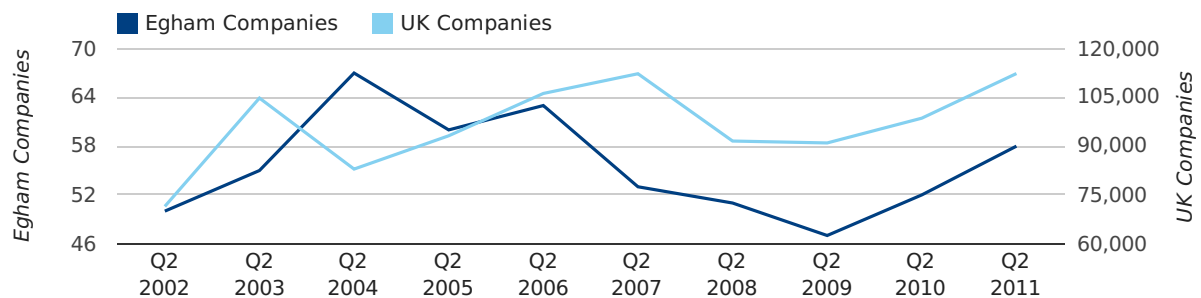
Quarterly Data (Q2 Apr-Jun 2011)

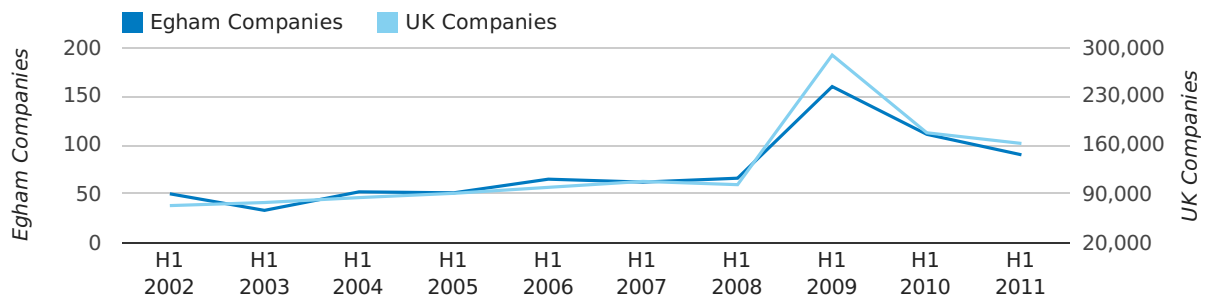
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 90 companies were dissolved in Egham. This figure is 18.9% lower than last year, which compares well to the UK wide change of -8.6%.

The highest total for a first half year in Egham occurred in 2009 when a total of 160 were closed.

dissolved companies by half year



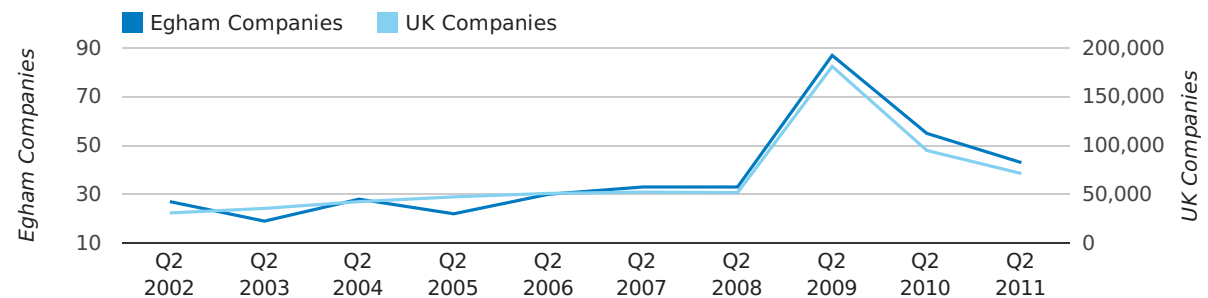
Quarterly Data (Q2 Apr-Jun 2011)

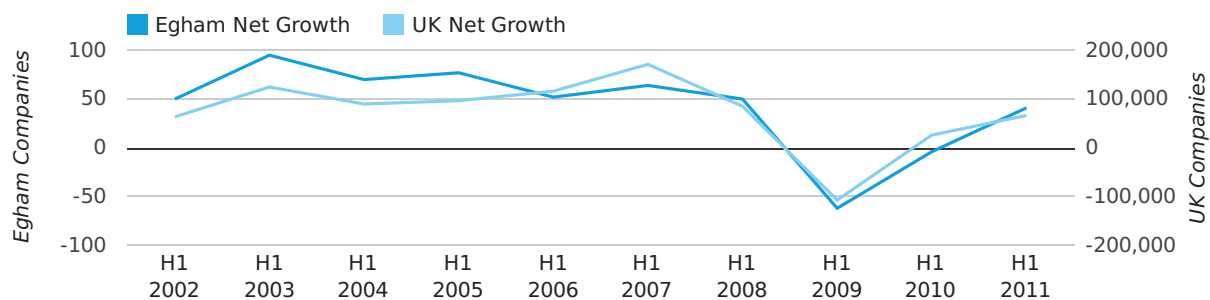

net growth by half year



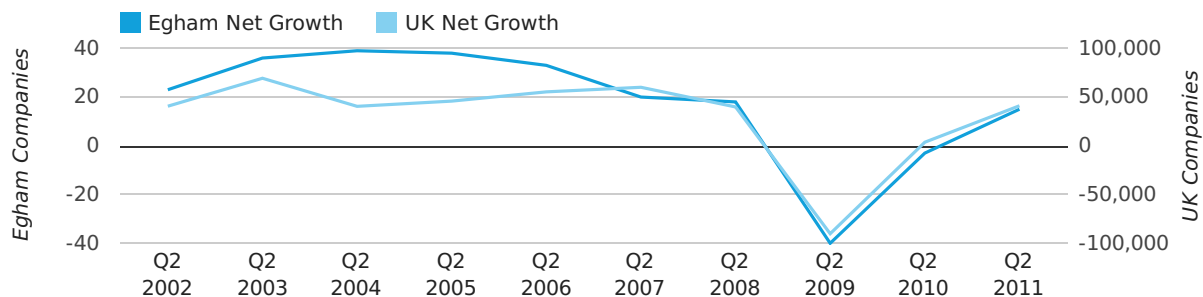

This represents an increase of 600.0% on the same period last year.

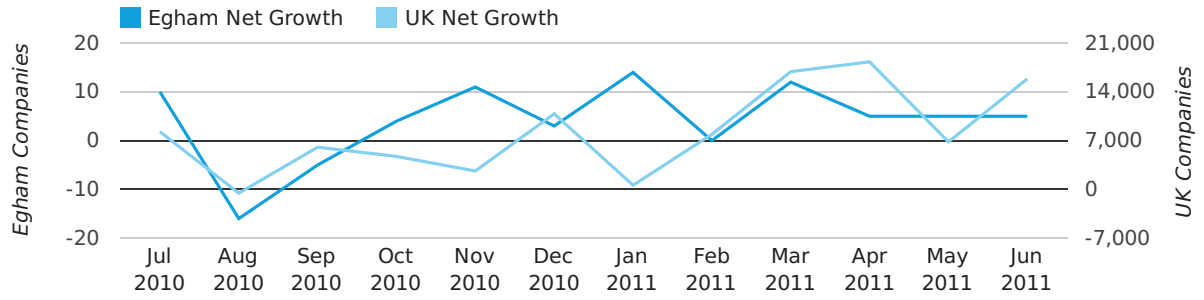

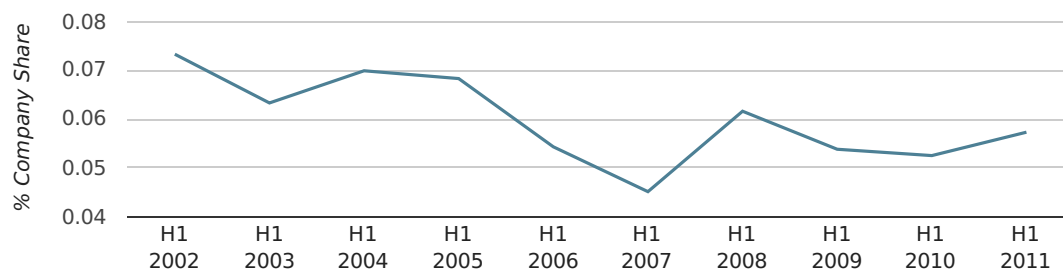

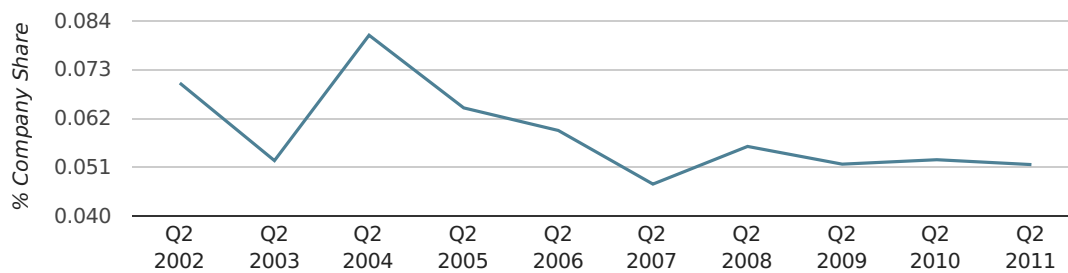

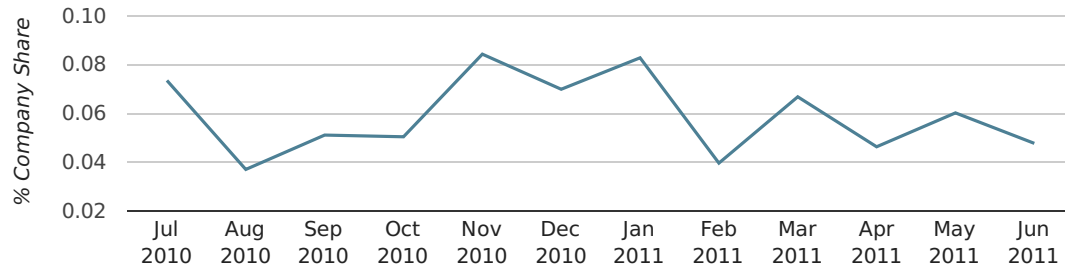

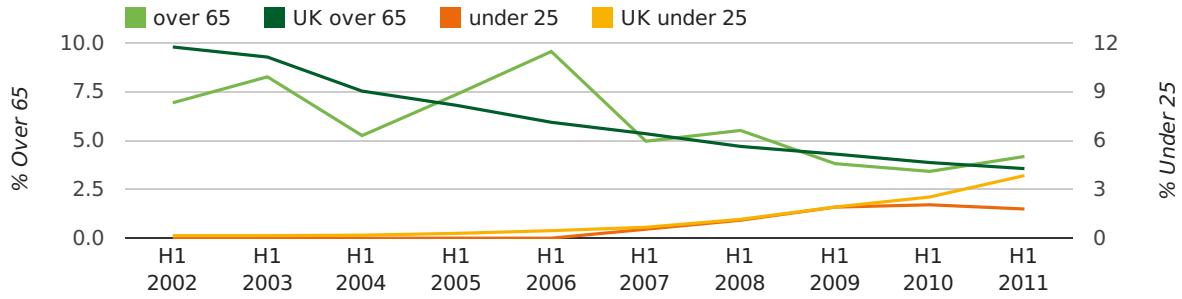

director age by half year



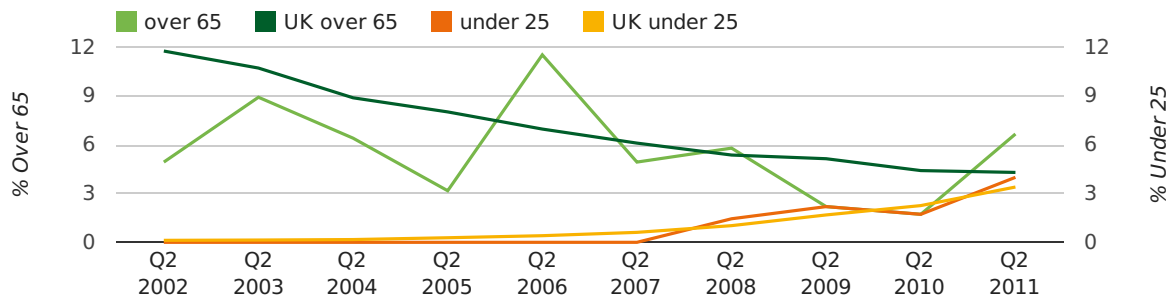

director age by quarter

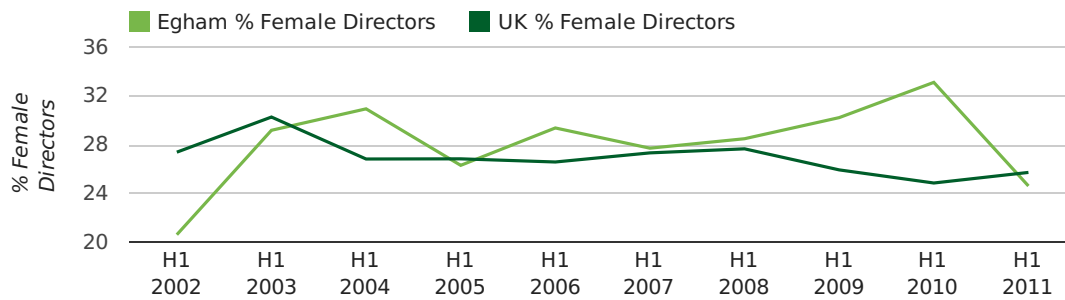


Half Year Data (Jan-Jun 2011)

director gender by half year

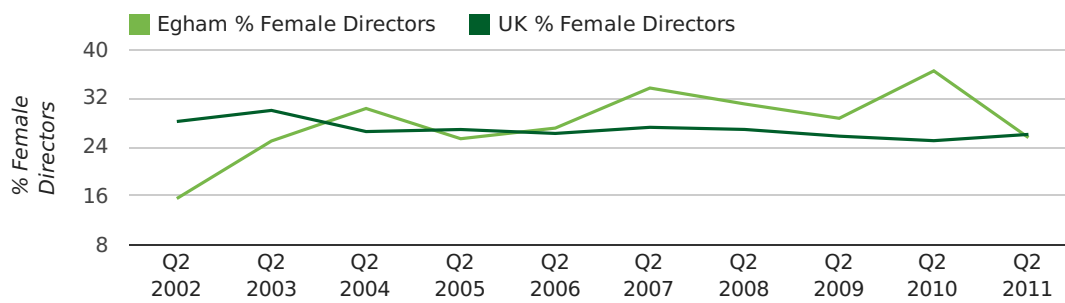


Quarterly Data (Q2 Apr-Jun 2011)
