
The first half of 2011 saw a new record in company registrations in Ely when compared to any previous first half year.

In the first half of 2011 a total of 185 companies were formed in Ely. This figure is 39.1% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Ely occurred in 2011 when a total of 185 were formed.

Q2 2011 saw a new record in company registrations in Ely when compared to any previous Q2.


Q2 2011 was a record quarter for company registrations in Ely when compared to any quarter in history.



#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)




Q2 2011 saw a new record in net growth in Ely when compared to any previous Q2.




company share by half year





#### director age by half year




## Quarterly Data (Q2 Apr-Jun 2011)

The record first half year for female directors in Ely was 1861 when 40.0% of all directors were female.

30.2% of all director appointments in Ely in the first half of 2011 were female. This compares to a UK average of 25.7% for the same period.

#### director gender by half year




## Quarterly Data (Q2 Apr-Jun 2011)
