

2011 was a record year for company registrations in Epsom when compared to any year in history.

A total of 589 companies were formed in Epsom in 2011. This total is 25.1% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

## Half Year Data (Jul-Dec 2011)

The second half of 2011 saw a new record in company registrations in Epsom when compared to any previous second half year.

In the second half of 2011 a total of 252 companies were formed in Epsom. This figure is 17.2% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Epsom occurred in 2011 when a total of 252 were formed.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Epsom when compared to any previous Q4.

A total of 129 companies were registered in Epsom during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





## dissolved companies by half year




Q4 2011 saw a new record in company closures in Epsom when compared to any previous Q4.

This figure is an increase of 34.3% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.




A total of 202 companies were added to the company register for Epsom in 2011. This number represents growth of 42.9% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Epsom during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 35 companies.

#### net growth by quarter






company share by year







#### director age by year




## Half Year Data (Jul-Dec 2011)

The percentage of directors over the age of 65 was 7.2% compared to the UK figure of 4.1%.




The average age of a director in the fourth quarter of 2011 was 45.8.

#### director gender by year




## Half Year Data (Jul-Dec 2011)

26.4% of all director appointments in Epsom in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


#### director gender by half year
