
The first half of 2012 saw a new record in company registrations in Essex when compared to any previous first half year.

In the first half of 2012 a total of 10,712 companies were formed in Essex. This figure is 12.3% higher than last year, which compares equally to the UK wide figure of 10.7%.


Quarterly Data (Q2 Apr-Jun 2012)



dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)









company share by half year





company share by month





director age by half year






director age by quarter
