




## Quarterly Data (Q2 Apr-Jun 2011)



#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)

A total of 28 companies were dissolved in Evesham during the second quarter of 2011 (Apr 2011 - Jun 2011).











company share by month





#### director age by half year





The percentage of directors over the age of 65 was 4.7% compared to the UK figure of 4.3%.


#### director age by quarter

#### director gender by half year




## Quarterly Data (Q2 Apr-Jun 2011)
