

new companies by year




Half Year Data (Jul-Dec 2011)

new companies by half year




A total of 182 companies were registered in Exeter during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


new companies by quarter




The second half of 2011 saw a new record in company closures in Exeter when compared to any previous second half year.

dissolved companies by half year




Q4 2011 saw a new record in company closures in Exeter when compared to any previous Q4.




A total of 200 companies were added to the company register for Exeter in 2011. This number represents growth of 30.3% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Exeter during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 32 companies.





company share by year




company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


