
The first half of 2012 saw a new record in company registrations in Farnham when compared to any previous first half year.

The first half of 2012 was a record first half year for company registrations in Farnham when compared to any half year in history.

In the first half of 2012 a total of 269 companies were formed in Farnham. This figure is 25.1% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Farnham occurred in 2012 when a total of 269 were formed.


Quarterly Data (Q2 Apr-Jun 2012)





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)





net growth by half year






company share by half year





director age by half year










The record first half year for female directors in Farnham was 1861 when 40.0% of all directors were female.

director gender by half year


