

A total of 530 companies were formed in Feltham in 2011. This total is 27.1% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Feltham when compared to any previous second half year.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Feltham when compared to any previous Q4.

#### new companies by quarter





#### new companies by month



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

## dissolved companies by half year




A total of 90 companies were dissolved in Feltham during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

#### dissolved companies by quarter




A total of 213 companies were added to the company register for Feltham in 2011. This number represents growth of 51.1% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Feltham during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 46 companies.


#### net growth by quarter



#### company share by year




#### company share by half year





#### director age by year





#### director age by half year




#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)
