


The second half of 2011 saw a new record in company registrations in Ferndown when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Ferndown when compared to any previous Q4.


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 13 companies were dissolved in Ferndown during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 65 companies were added to the company register for Ferndown in 2011. This number represents growth of 61.3% which compares favourably to the UK figure of 34.6%.

net growth by year





net growth by half year






net growth by quarter

net growth by month








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year


