

#### Half Year Data (Jul-Dec 2011)

The second half of 2011 saw a new record in company registrations in Frome when compared to any previous second half year.

In the second half of 2011 a total of 86 companies were formed in Frome. This figure is 36.5% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Frome occurred in 2011 when a total of 86 were formed.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Frome when compared to any previous Q4.


#### new companies by quarter



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 50 companies were dissolved in Frome. This figure is 22.0% higher than last year, which compares badly to the UK wide change of -7.5%.

## dissolved companies by half year




A total of 29 companies were dissolved in Frome during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### dissolved companies by quarter


A total of 52 companies were added to the company register for Frome in 2011. This number represents growth of 37.4% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Frome during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 8 companies.


#### net growth by quarter

#### net growth by month



#### company share by year




#### company share by half year





#### director age by year




## Half Year Data (Jul-Dec 2011)

#### director age by half year




The average age of a director in the fourth quarter of 2011 was 45.6.

#### director gender by year




## Half Year Data (Jul-Dec 2011)

#### director gender by half year


