


The second half of 2011 saw a new record in company registrations in Gateshead when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Gateshead when compared to any previous Q4.





dissolved companies by half year




Q4 2011 saw a new record in company closures in Gateshead when compared to any previous Q4.


A total of 183 companies were added to the company register for Gateshead in 2011. This number represents growth of 36.2% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Gateshead during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 26 companies.

net growth by quarter






company share by year



company share by half year





director age by year





director age by half year



director age by quarter





director gender by year




Half Year Data (Jul-Dec 2011)

24.5% of all director appointments in Gateshead in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
