The first half of 2012 saw a new record in company registrations in Gateshead when compared to any previous first half year.


The first half of 2012 was a record first half year for company registrations in Gateshead when compared to any half year in history.

In the first half of 2012 a total of 336 companies were formed in Gateshead. This figure is 17.1% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Gateshead occurred in 2012 when a total of 336 were formed.




A total of 149 companies were registered in Gateshead during the second quarter of 2012 (Apr 2012 - Jun 2012).



The highest total for a first half year in Gateshead occurred in 2009 when a total of 300 were closed.








Net company growth for Gateshead during the second quarter of 2012 (Apr 2012 - Jun 2012) was 60 companies.




company share by half year





#### director age by half year



The percentage of directors over the age of 65 was 1.9% compared to the UK figure of 3.3%.




#### director age by quarter

24.6% of all director appointments in Gateshead in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.


#### director gender by half year



## Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Gateshead was in 1866 when 66.7% of all directors were female.

20.3% of all director appointments in Gateshead in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
