Q3 2011 saw a new record in company registrations in Gillingham when compared to any previous Q3.


Q3 2011 was a record quarter for company registrations in Gillingham when compared to any quarter in history.

A total of 120 companies were registered in Gillingham during the third quarter of 2011 (Jul 2011 - Sep 2011).

This figure is an increase of 3.4% versus the same period last year (Q3 2010). This figure compares badly to the UK as a whole, which saw an increase of 12.8% against the same period last year.

new companies by month




A total of 64 companies were dissolved in Gillingham during the third quarter of 2011 (Jul 2011 - Sep 2011).












