

In the first half of 2011 a total of 3,204 companies were formed in Glasgow. This figure is 7.5% higher than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Glasgow occurred in 2007 when a total of 3,237 were formed.




## Quarterly Data (Q2 Apr-Jun 2011)



#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)

This figure is a decrease of 44.2% versus the same period last year (Q2 2010). This figure compares well to the UK as a whole, which saw a decrease of 24.9% against the same period last year.






## Quarterly Data (Q2 Apr-Jun 2011)

June 2011 saw a new record in net growth in Glasgow when compared to any previous June.




company share by half year






## Half Year Data (Jan-Jun 2011)



### director gender by half year




## Quarterly Data (Q2 Apr-Jun 2011)

The record second quarter for female directors in Glasgow was in 1866 when 66.7% of all directors were female.
