

A total of 193 companies were formed in Glossop in 2011. This total is 25.3% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

The second half of 2011 saw a new record in company registrations in Glossop when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Glossop when compared to any half year in history.

Q4 2011 saw a new record in company registrations in Glossop when compared to any previous Q4.

A total of 50 companies were registered in Glossop during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 56.3% versus the same period last year (Q4 2010). This figure compares well to the UK as a whole, which saw an increase of 15.3% against the same period last year.



new companies by month



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 24 companies were dissolved in Glossop during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 87 companies were added to the company register for Glossop in 2011. This number represents growth of 56.5% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)




Net company growth for Glossop during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 26 companies.






company share by year



company share by half year





director age by year








director gender by year




Half Year Data (Jul-Dec 2011)
