The first half of 2011 saw a new record in company registrations in Godalming when compared to any previous first half year.

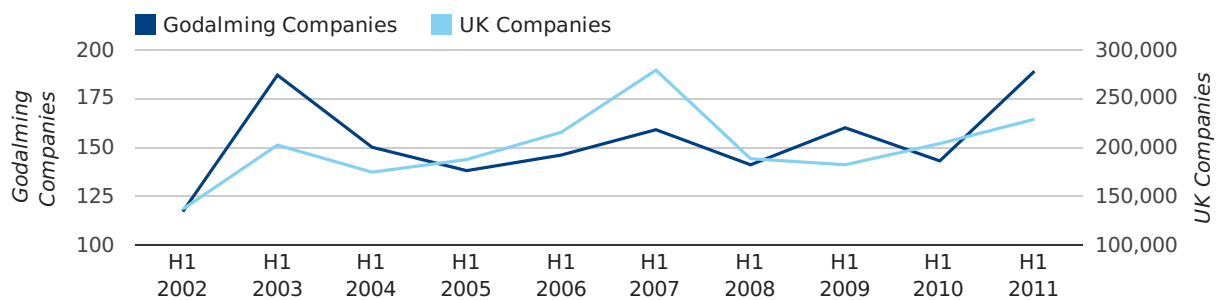
The first half of 2011 was a record first half year for company registrations in Godalming when compared to any half year in history.

In the first half of 2011 a total of 189 companies were formed in Godalming. This figure is 32.2% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Godalming occurred in 2011 when a total of 189 were formed.

new companies by half year



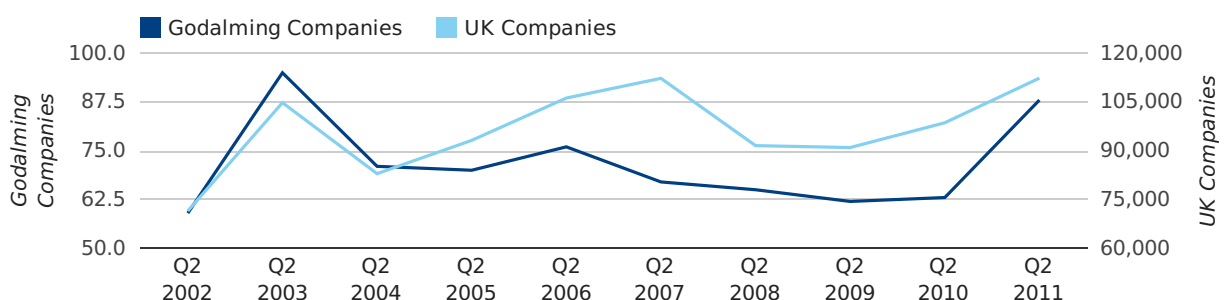
Quarterly Data (Q2 Apr-Jun 2011)

new companies by quarter

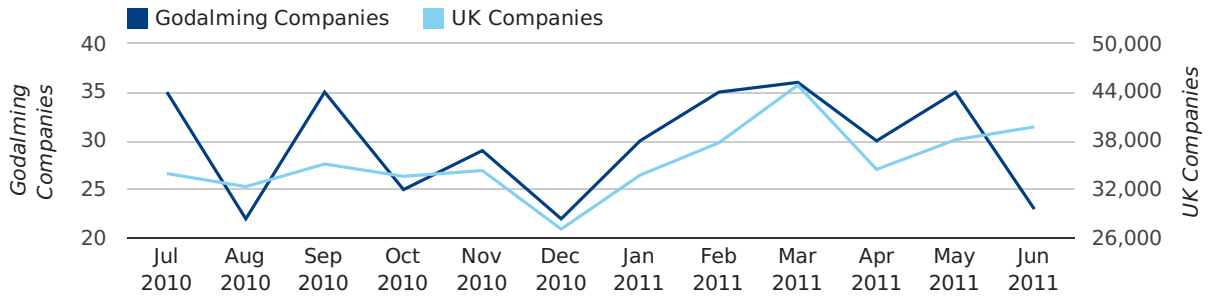

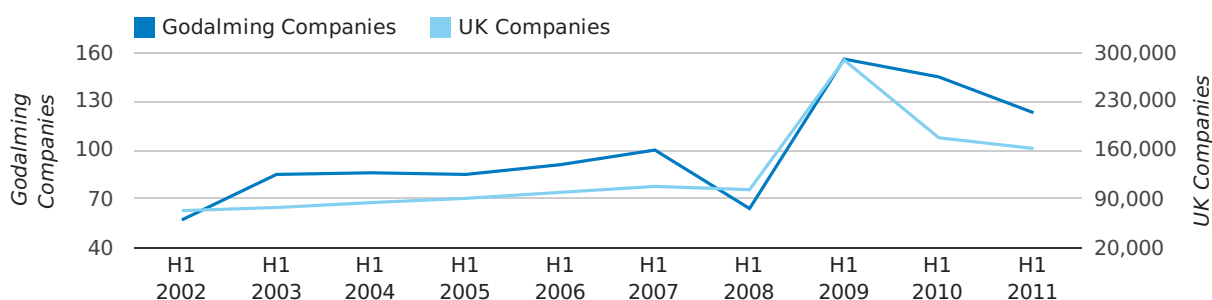
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 123 companies were dissolved in Godalming. This figure is 15.2% lower than last year, which compares well to the UK wide change of -8.6%.

The highest total for a first half year in Godalming occurred in 2009 when a total of 156 were closed.

dissolved companies by half year



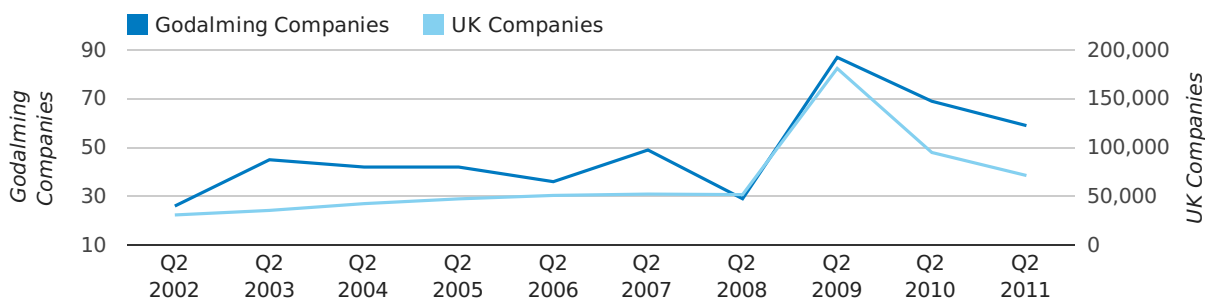
Quarterly Data (Q2 Apr-Jun 2011)

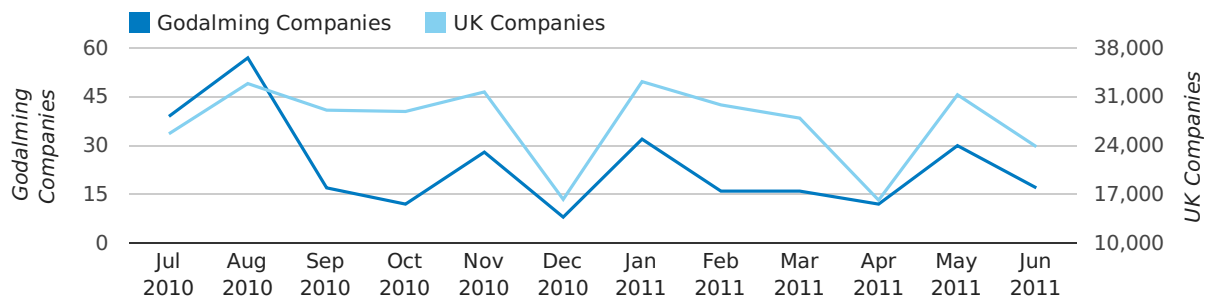

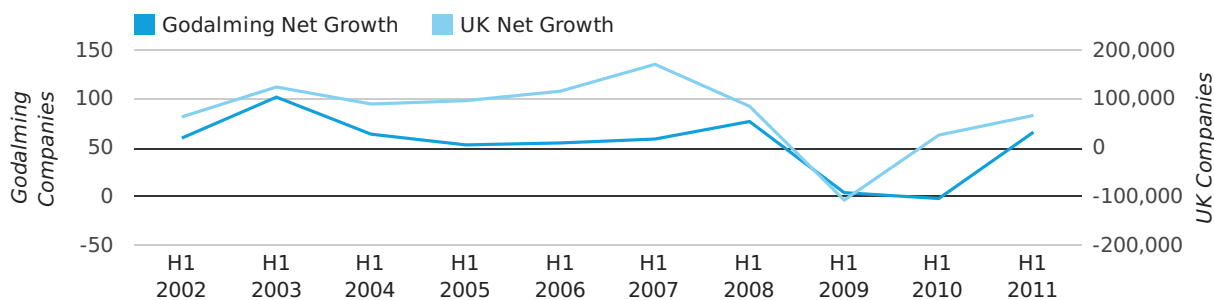

net growth by half year



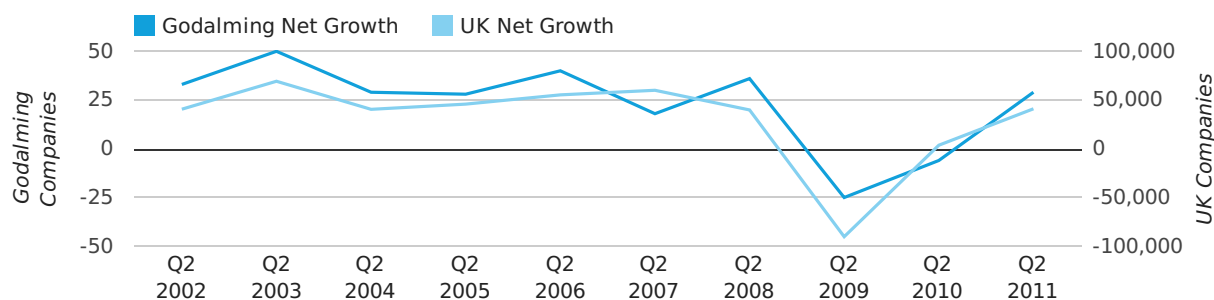

This represents an increase of 583.3% on the same period last year.

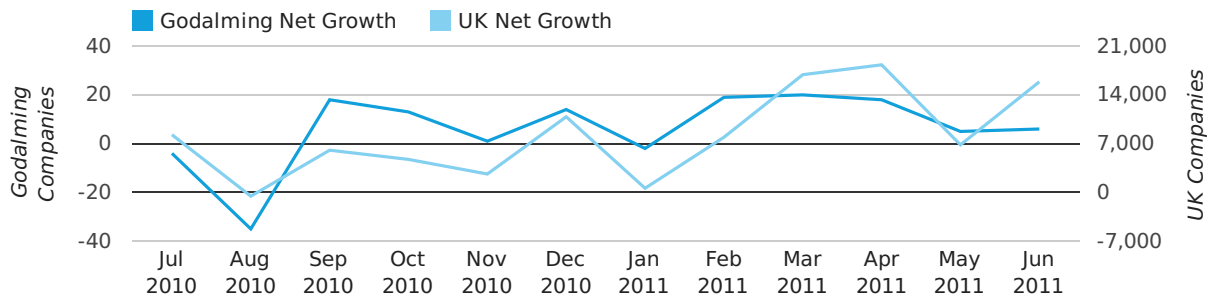

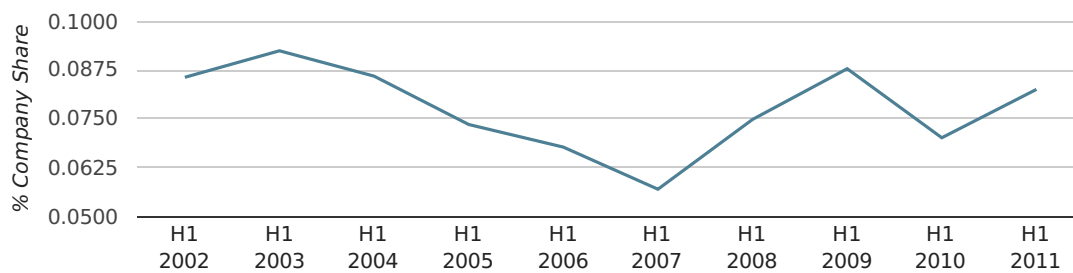

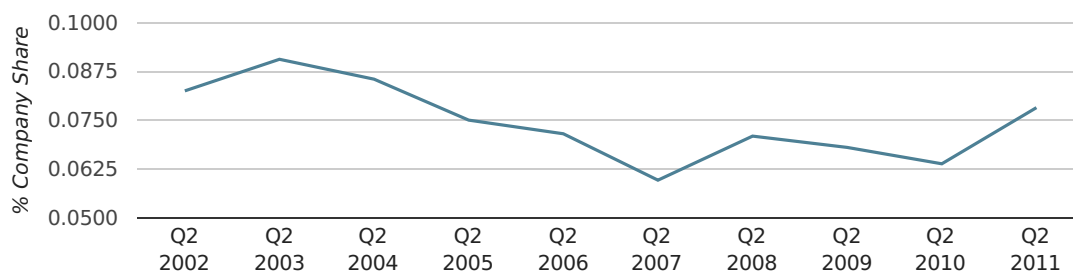

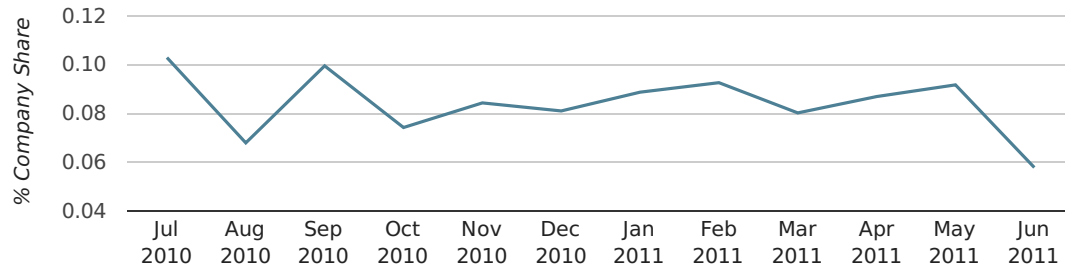

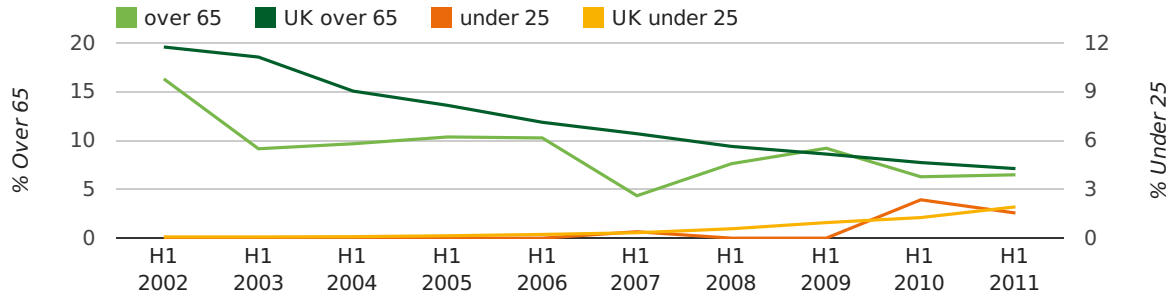

director age by half year



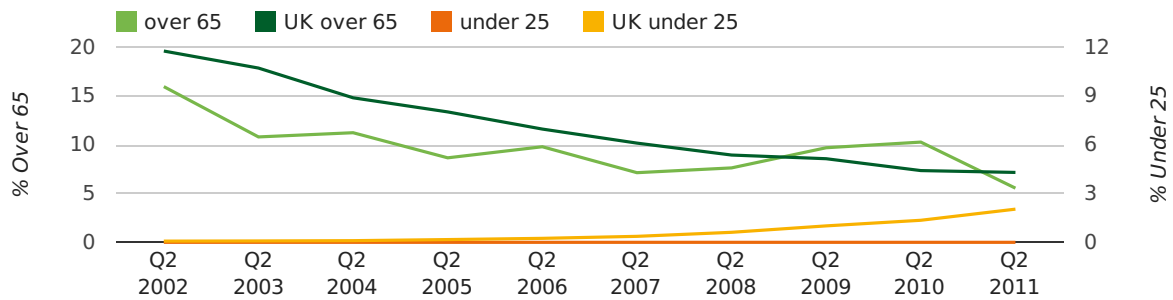

director age by quarter

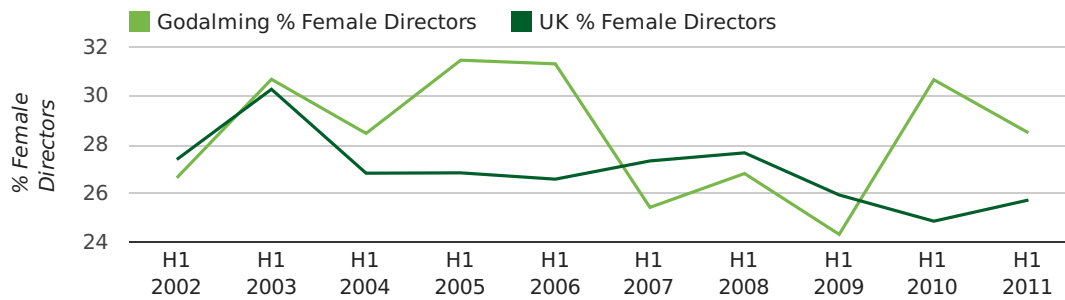


Half Year Data (Jan-Jun 2011)

director gender by half year

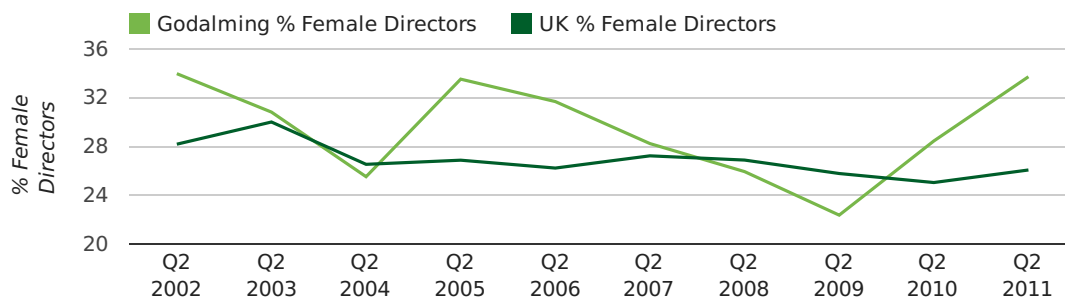


Quarterly Data (Q2 Apr-Jun 2011)
