

In the first half of 2012 a total of 198 companies were formed in Godalming. This figure is 4.8% higher than last year, which compares badly to the UK wide figure of 10.7%.


Quarterly Data (Q2 Apr-Jun 2012)








Quarterly Data (Q2 Apr-Jun 2012)





net growth by half year










company share by half year





director age by half year










The record first half year for female directors in Godalming was 1861 when 40.0% of all directors were female.

director gender by half year


