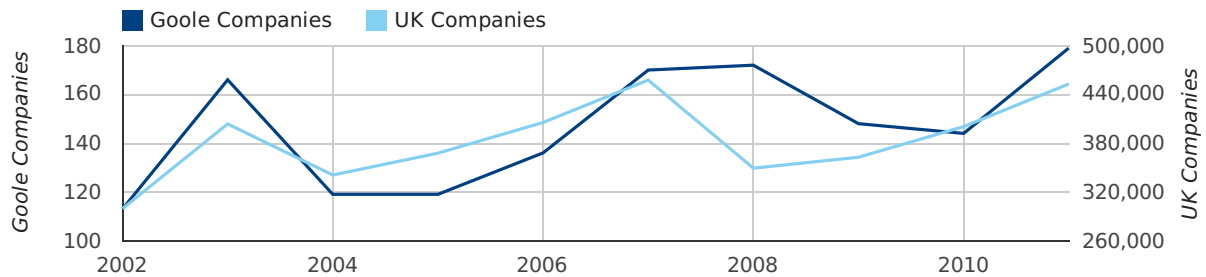
## Annual Data (2011)

2011 was a record year for company registrations in Goole when compared to any year in history.

A total of 179 companies were formed in Goole in 2011. This total is 24.3% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

## Half Year Data (Jul-Dec 2011)

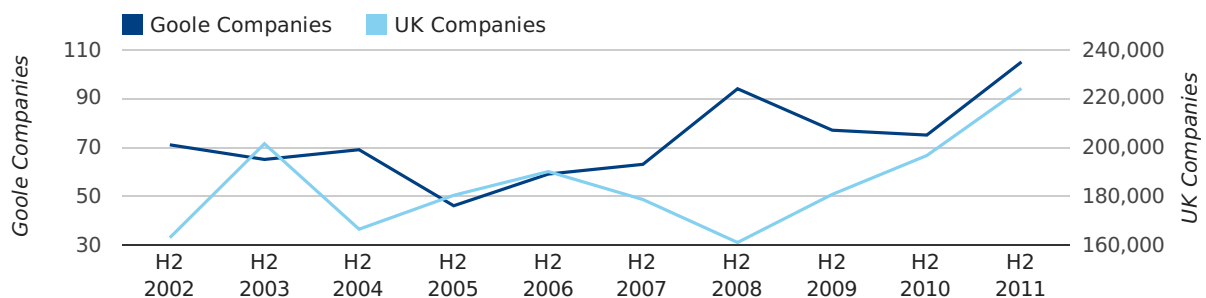
The second half of 2011 saw a new record in company registrations in Goole when compared to any previous second half year.

## Quarterly Data (Q4 Oct-Dec 2011)

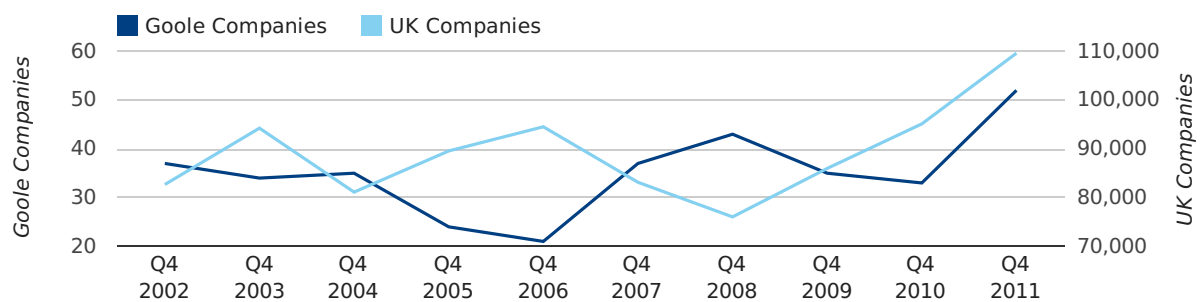
Q4 2011 saw a new record in company registrations in Goole when compared to any previous Q4.

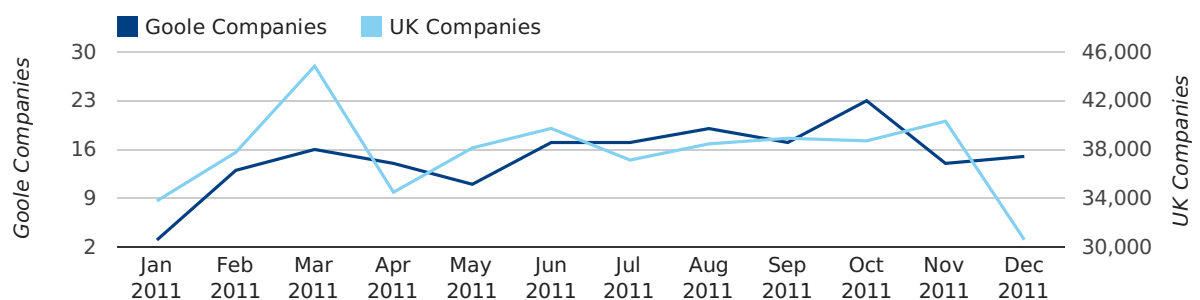


## Monthly Data (Oct, Nov & Dec 2011)

### dissolved companies by year



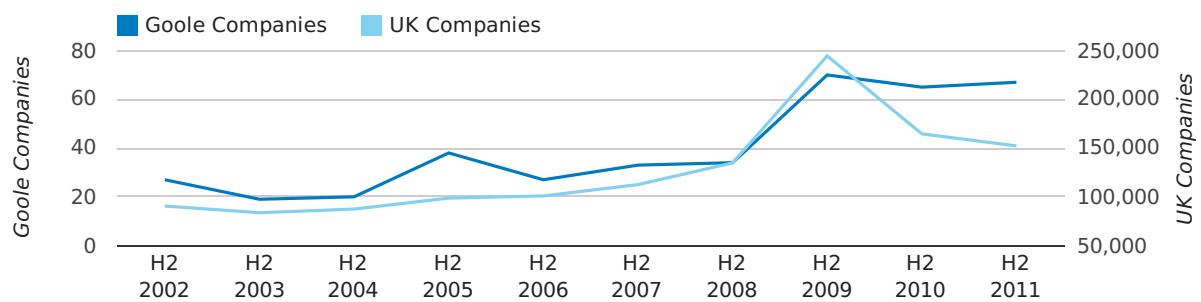
### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 67 companies were dissolved in Goole. This figure is 3.1% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Goole occurred in 2009 when a total of 70 were closed.

## Quarterly Data (Q4 Oct-Dec 2011)

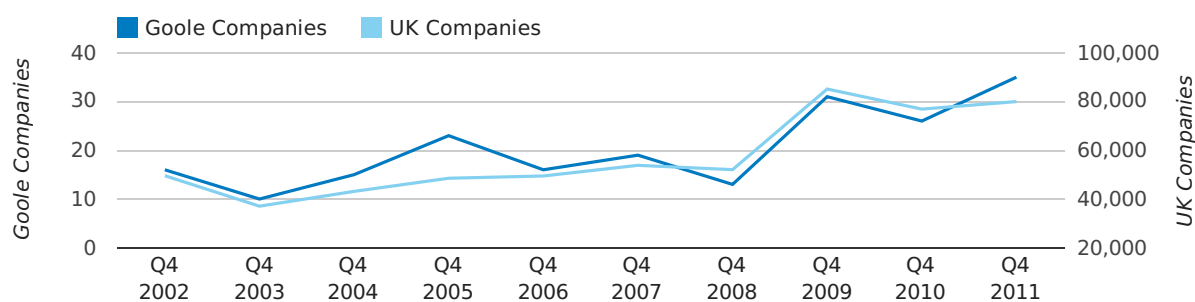
Q4 2011 saw a new record in company closures in Goole when compared to any previous Q4.

A total of 35 companies were dissolved in Goole during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 34.6% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.

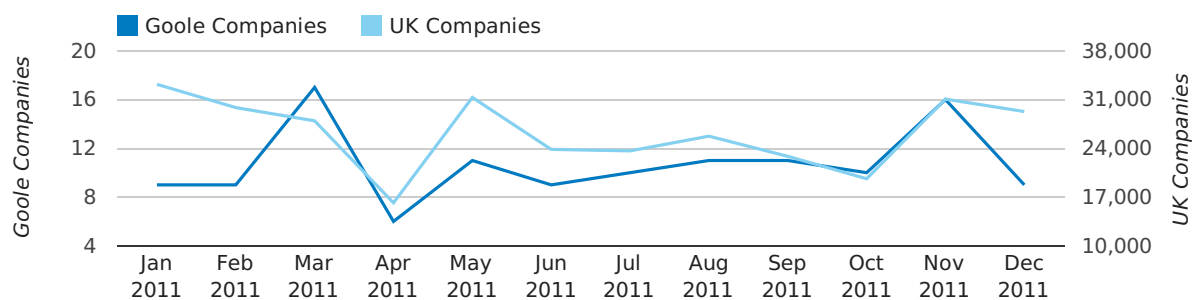
### dissolved companies by quarter

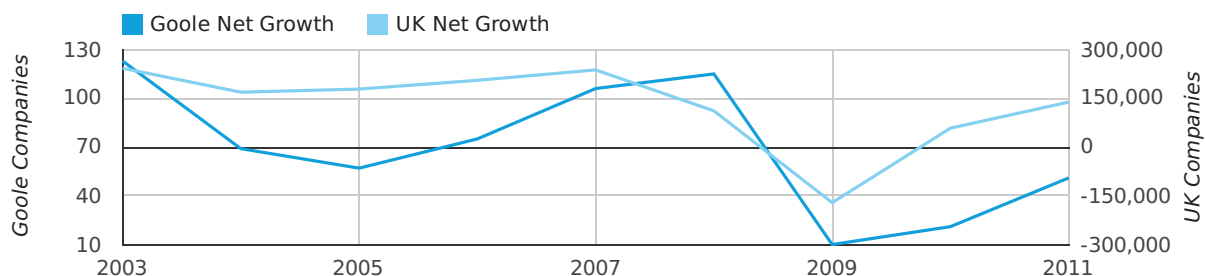
A total of 51 companies were added to the company register for Goole in 2011. This number represents growth of 35.4% which compares favourably to the UK figure of 34.6%.

### net growth by year

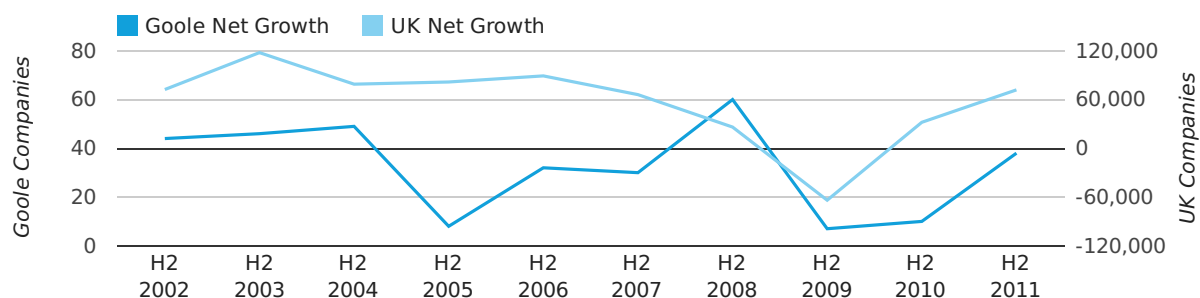


### Half Year Data (Jul-Dec 2011)

### net growth by half year



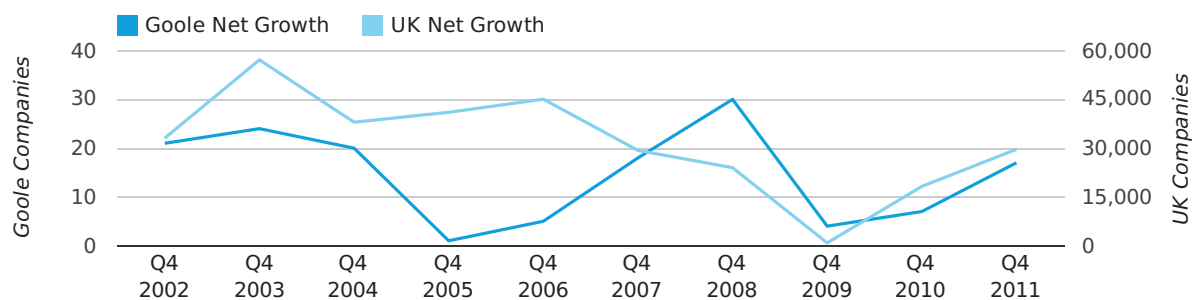
## Quarterly Data (Q4 Oct-Dec 2011)

This represents an increase of 142.9% on the same period last year.

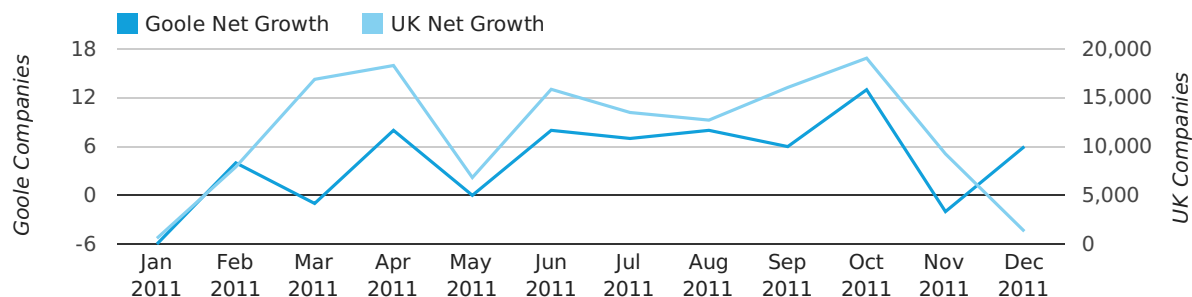

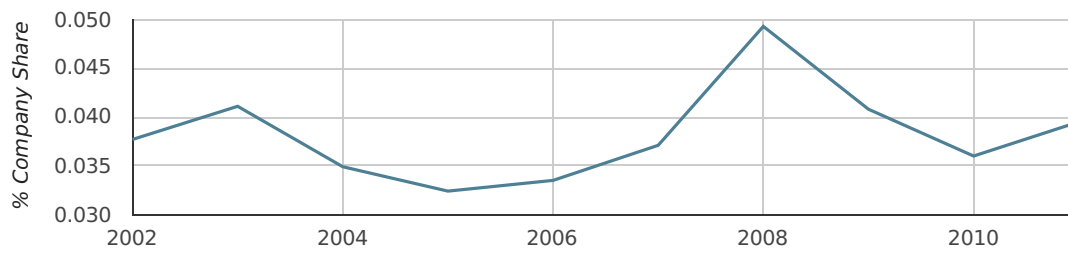

### company share by year

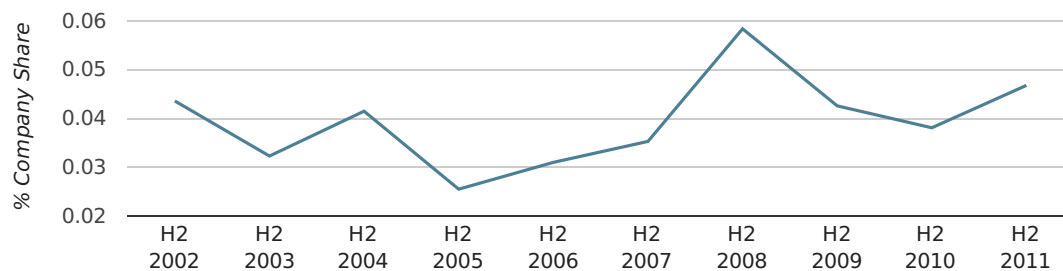

### company share by half year

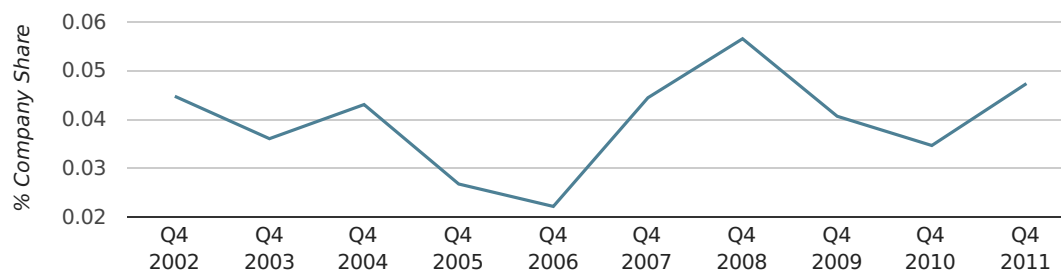

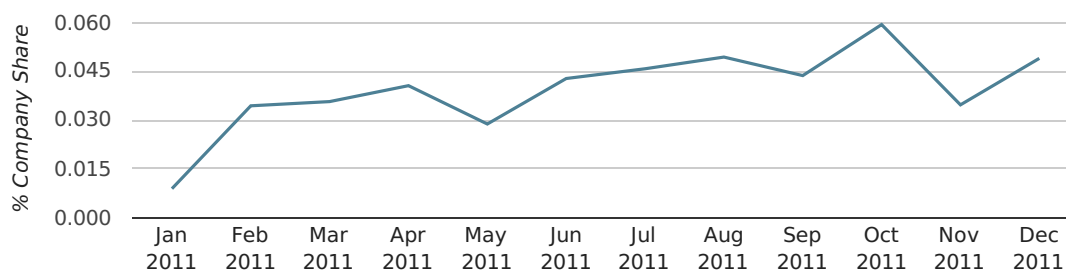

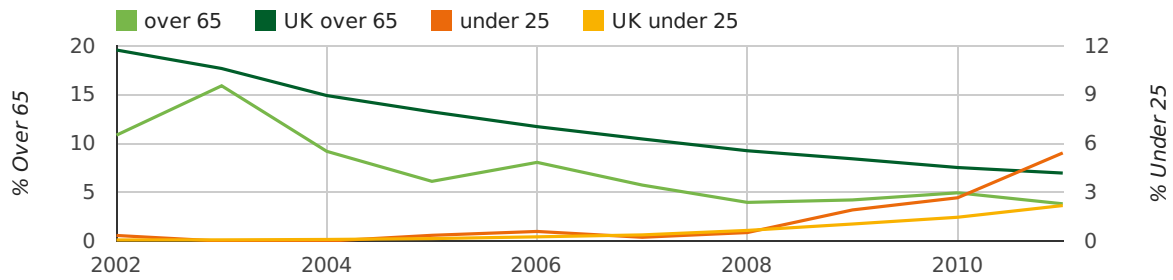

#### director age by year



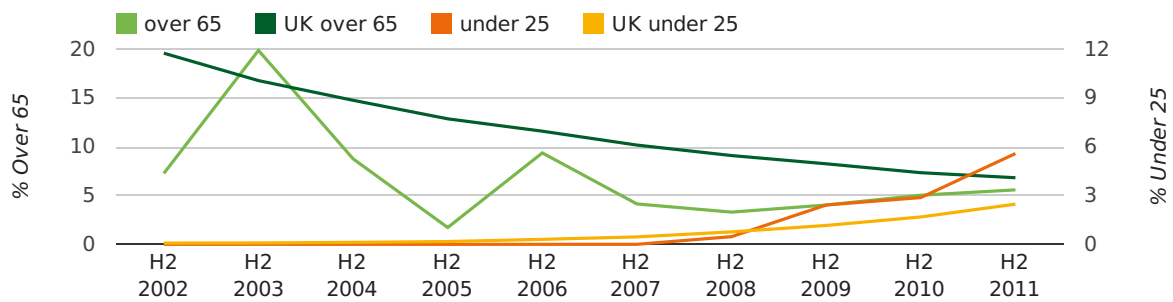

#### director age by half year



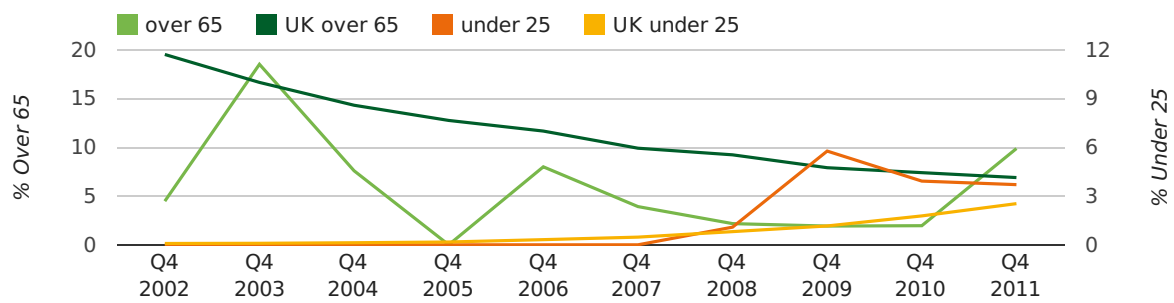

### director age by quarter

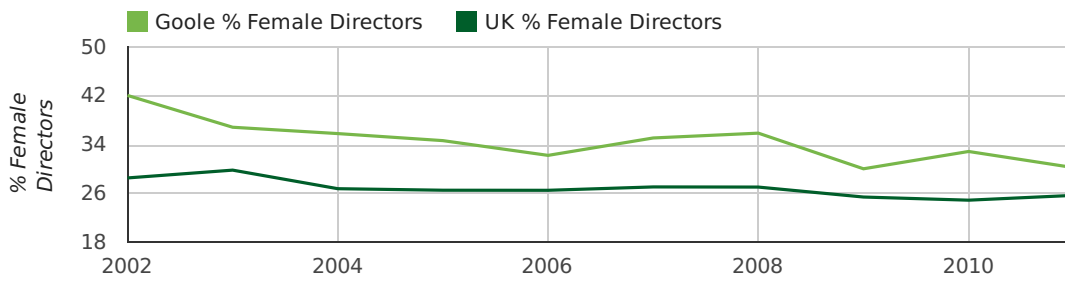


### Annual Data (2011)

#### director gender by year

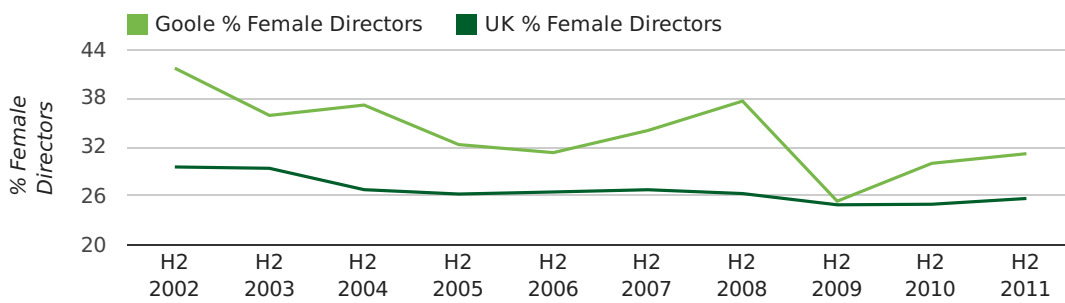


### Half Year Data (Jul-Dec 2011)

#### director gender by half year

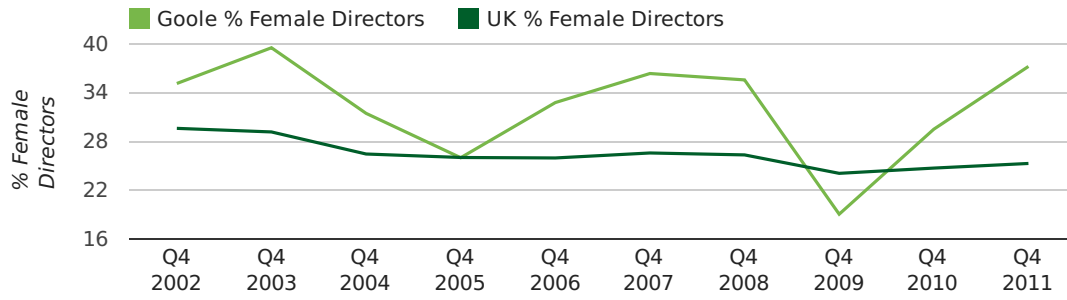


## Quarterly Data (Q4 Oct-Dec 2011)
