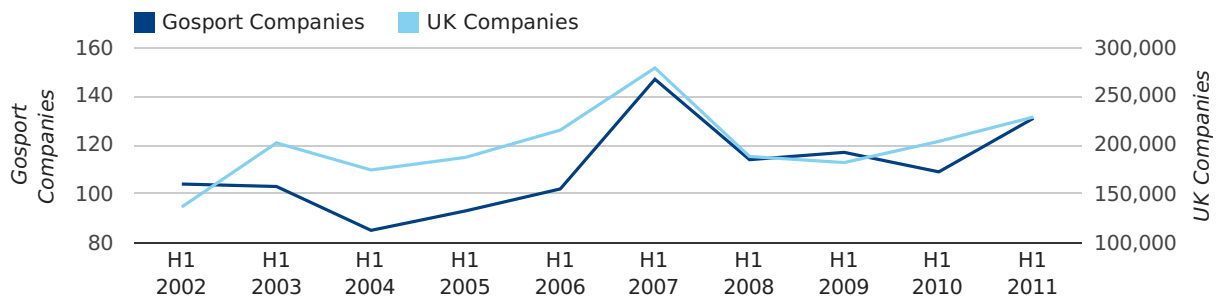
Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 131 companies were formed in Gosport. This figure is 20.2% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Gosport occurred in 2007 when a total of 147 were formed.

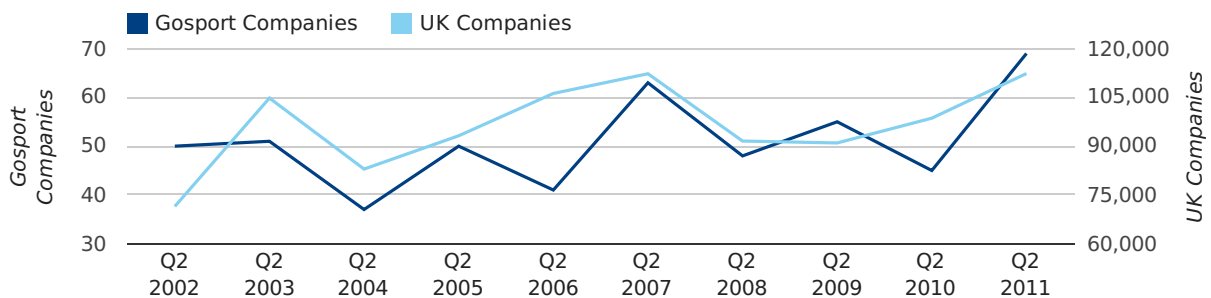
Q2 2011 saw a new record in company registrations in Gosport when compared to any previous Q2.

A total of 69 companies were registered in Gosport during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is an increase of 53.3% versus the same period last year (Q2 2010). This figure compares well to the UK as a whole, which saw an increase of 13.9% against the same period last year.

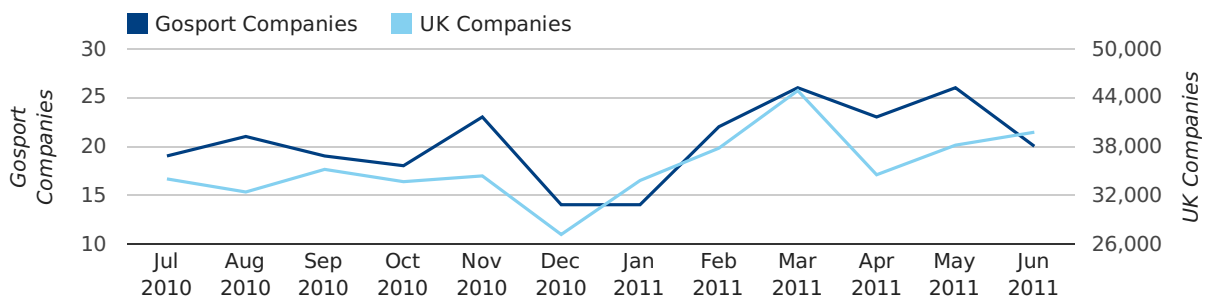
new companies by quarter

Half Year Data (Jan-Jun 2011)

In the first half of 2011 a total of 96 companies were dissolved in Gosport. This figure is 17.1% higher than last year, which compares badly to the UK wide change of -8.6%.

The highest total for a first half year in Gosport occurred in 2009 when a total of 148 were closed.

dissolved companies by half year



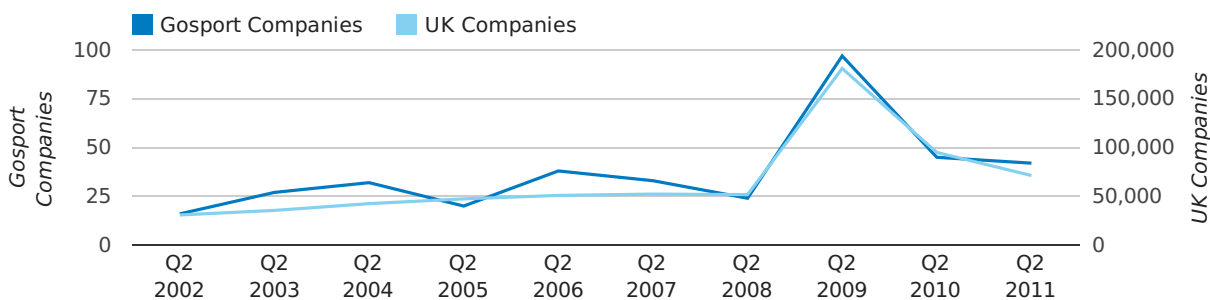
Quarterly Data (Q2 Apr-Jun 2011)

A total of 42 companies were dissolved in Gosport during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is a decrease of 6.7% versus the same period last year (Q2 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 24.9% against the same period last year.

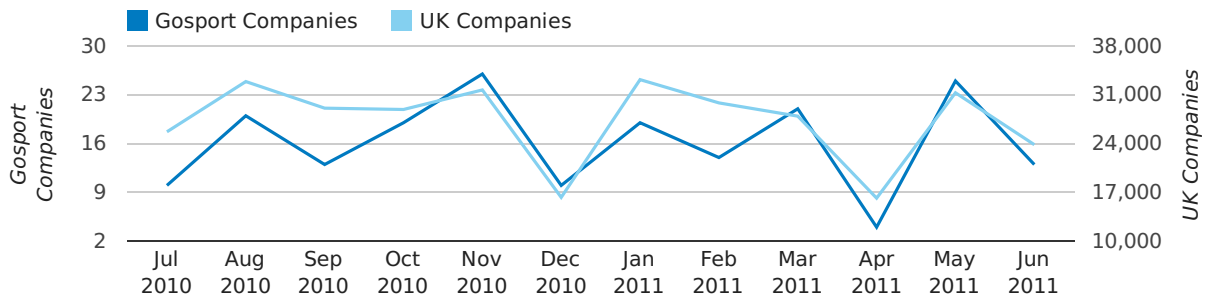

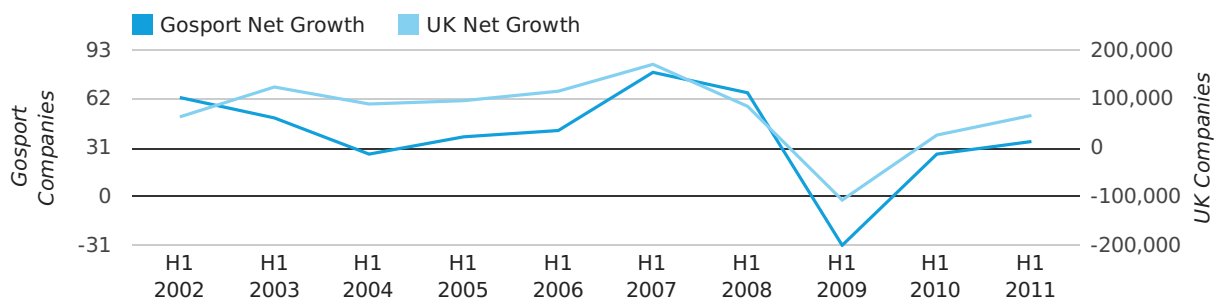

net growth by half year



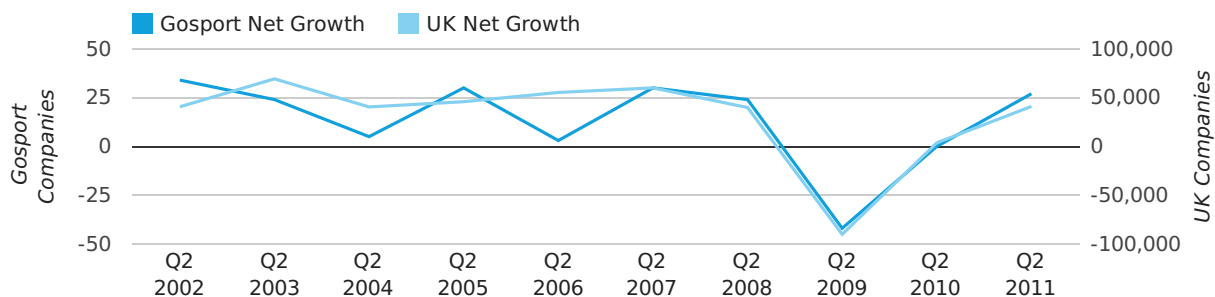

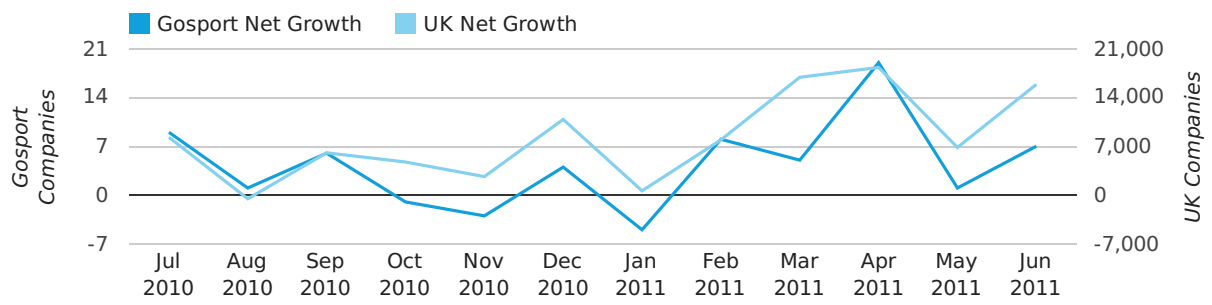
net growth by quarter

net growth by month



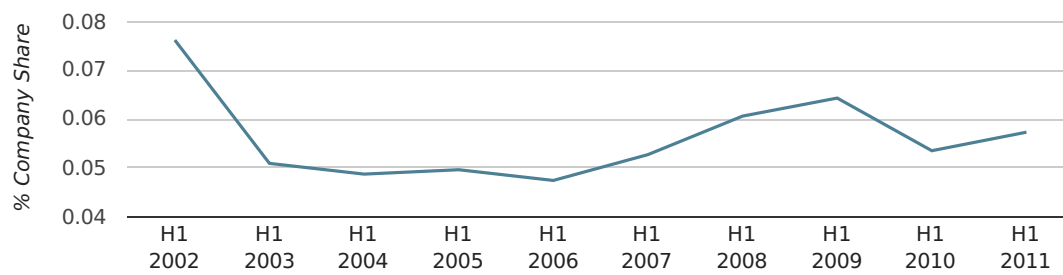

company share by half year

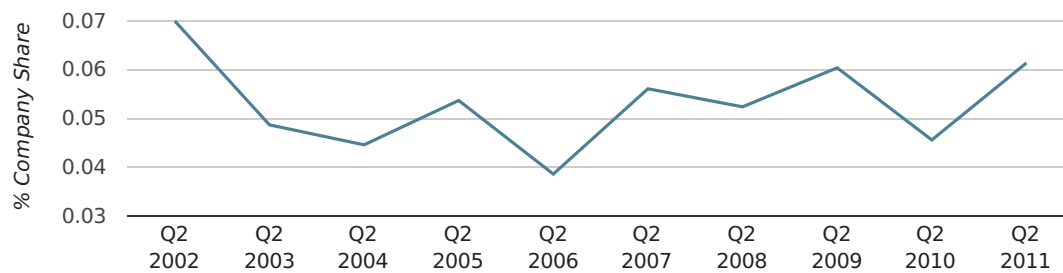

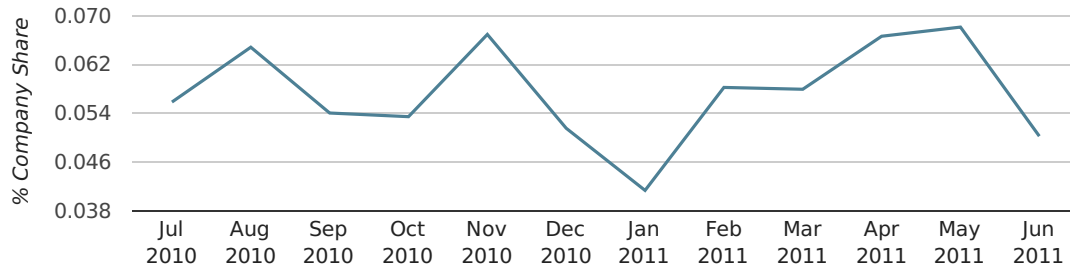

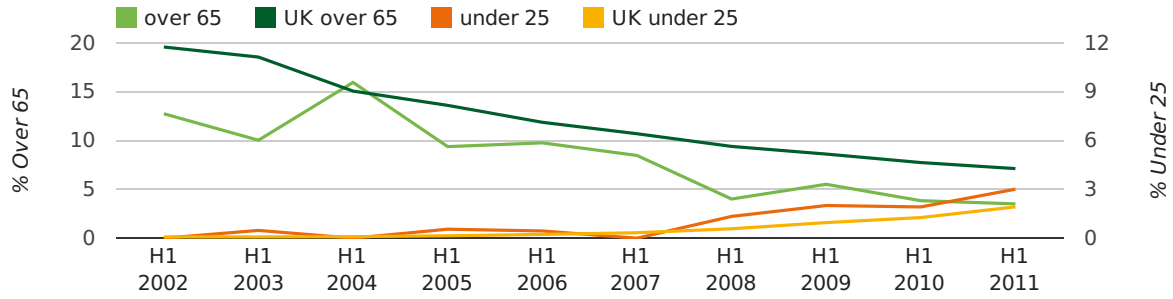

director age by half year



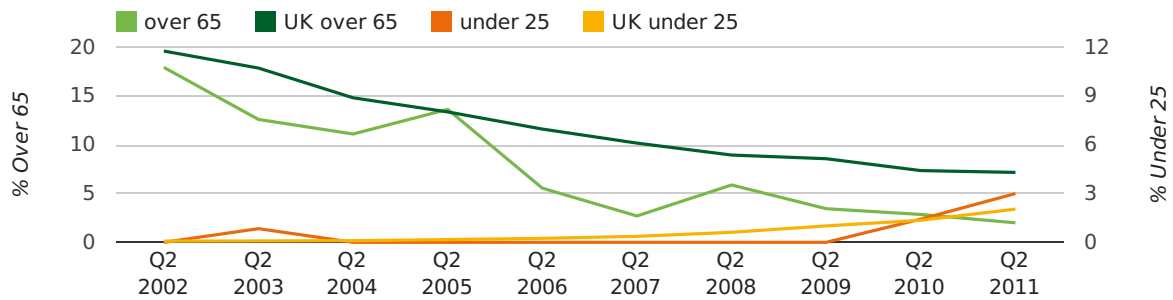

director age by quarter

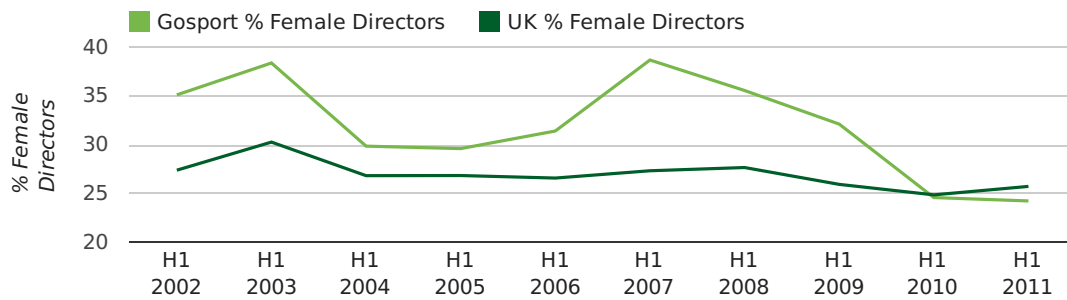


Half Year Data (Jan-Jun 2011)

director gender by half year

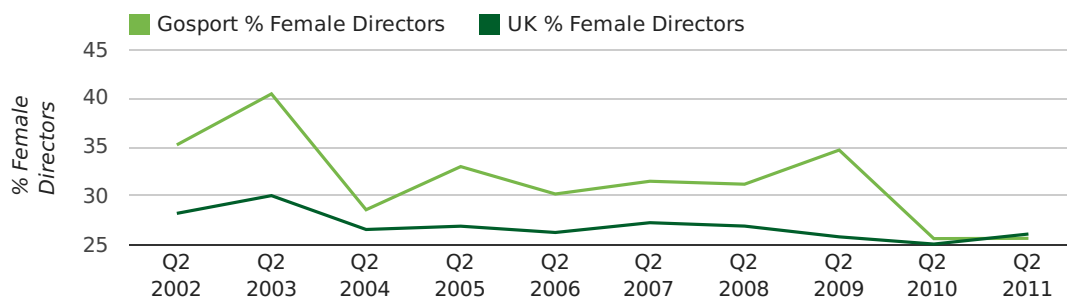


Quarterly Data (Q2 Apr-Jun 2011)
