

#### Quarterly Data (Q4 Oct-Dec 2011)


Q4 2011 saw a new record in company registrations in Grantham when compared to any previous Q4.





dissolved companies by year




# Half Year Data (Jul-Dec 2011)

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Grantham when compared to any previous Q4.


A total of 104 companies were added to the company register for Grantham in 2011. This number represents growth of 34.2% which compares unfavourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Grantham during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 11 companies.

#### net growth by quarter






company share by year




company share by half year





#### director age by half year



#### director gender by year




# Half Year Data (Jul-Dec 2011)

33.5% of all director appointments in Grantham in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


#### director gender by half year
