

A total of 699 companies were formed in Gravesend in 2011. This total is 6.7% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Gravesend when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Gravesend when compared to any previous Q4.





dissolved companies by year




Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 258 companies were dissolved in Gravesend. This figure is 6.2% lower than last year, which compares badly to the UK wide change of -7.5%.

dissolved companies by half year




Q4 2011 saw a new record in company closures in Gravesend when compared to any previous Q4.

A total of 143 companies were dissolved in Gravesend during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 25.4% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.




A total of 167 companies were added to the company register for Gravesend in 2011. This number represents growth of 25.5% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Gravesend during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 38 companies.

This represents an increase of 26.7% on the same period last year.



net growth by month






company share by half year





director age by year





director age by half year



director gender by year


