
The first half of 2012 was a record first half year for company registrations in Gravesend when compared to any half year in history.

Q2 2012 saw a new record in company registrations in Gravesend when compared to any previous Q2.


Q2 2012 was a record quarter for company registrations in Gravesend when compared to any quarter in history.

#### new companies by month



#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)












company share by half year





#### director age by half year



The percentage of directors over the age of 65 was 2.1% compared to the UK figure of 3.3%.




#### director age by quarter

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2012)
