

2011 was a record year for company registrations in Guildford when compared to any year in history.

A total of 822 companies were formed in Guildford in 2011. This total is 7.0% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Guildford when compared to any previous second half year.




A total of 173 companies were registered in Guildford during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 178 companies were dissolved in Guildford during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 184 companies were added to the company register for Guildford in 2011. This number represents growth of 24.0% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Guildford during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was -5 companies.

This represents a decrease of 112.5% on the same period last year.








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year


