




In the first half of 2012 a total of 129 companies were formed in Gwynedd. This figure is 0.8% lower than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Gwynedd occurred in 2007 when a total of 157 were formed.

### new companies by half year




### Quarterly Data (Q2 Apr-Jun 2012)





### dissolved companies by half year




### Quarterly Data (Q2 Apr-Jun 2012)





### net growth by half year















### director age by half year





The percentage of directors over the age of 65 was 6.3% compared to the UK figure of 3.3%.


### director age by quarter
