




Quarterly Data (Q2 Apr-Jun 2011)

A total of 55 companies were registered in Hailsham during the second quarter of 2011 (Apr 2011 - Jun 2011).







A total of 54 companies were dissolved in Hailsham during the second quarter of 2011 (Apr 2011 - Jun 2011).







net growth by quarter






company share by half year





director age by half year






director age by quarter
