

#### new companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)

A total of 45 companies were registered in Hailsham during the second quarter of 2012 (Apr 2012 - Jun 2012).





#### dissolved companies by half year





A total of 35 companies were dissolved in Hailsham during the second quarter of 2012 (Apr 2012 - Jun 2012).





## net growth by half year













#### director age by half year




## Quarterly Data (Q2 Apr-Jun 2012)

#### director gender by half year




## Quarterly Data (Q2 Apr-Jun 2012)
