


Quarterly Data (Q2 Apr-Jun 2011)




Half Year Data (Jan-Jun 2011)

This figure is a decrease of 22.2% versus the same period last year (Q2 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 24.9% against the same period last year.



net growth by half year




Net company growth for Halifax during the second quarter of 2011 (Apr 2011 - Jun 2011) was 81 companies.

net growth by quarter





company share by half year





company share by month





director age by half year






director age by quarter

director gender by half year


