


new companies by half year





dissolved companies by year




Half Year Data (Jul-Dec 2011)




A total of 73 companies were dissolved in Hamilton during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 154 companies were added to the company register for Hamilton in 2011. This number represents growth of 36.4% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)




Net company growth for Hamilton during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 40 companies.


company share by year







director age by year







