

A total of 539 companies were formed in Harlow in 2011. This total is 22.5% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Harlow when compared to any previous second half year.

In the second half of 2011 a total of 284 companies were formed in Harlow. This figure is 22.9% higher than last year, which compares well to the UK wide figure of 14.0%.

#### new companies by half year




A total of 136 companies were registered in Harlow during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### new companies by quarter



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 152 companies were dissolved in Harlow. This figure is 0.7% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Harlow occurred in 2009 when a total of 160 were closed.

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Harlow when compared to any previous Q4.

A total of 89 companies were dissolved in Harlow during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 25.4% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.

#### dissolved companies by quarter




A total of 256 companies were added to the company register for Harlow in 2011. This number represents growth of 58.2% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Harlow during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 47 companies.


#### net growth by quarter






#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 41.4.

The percentage of directors over the age of 65 was 2.7% compared to the UK figure of 4.1%.


#### director age by quarter

#### director gender by half year


