
The first half of 2011 was a record first half year for company registrations in Harrogate when compared to any half year in history.

Q2 2011 saw a new record in company registrations in Harrogate when compared to any previous Q2.


Q2 2011 was a record quarter for company registrations in Harrogate when compared to any quarter in history.









net growth by quarter



net growth by month





company share by half year





company share by month





director age by half year





director gender by half year


