

2011 was a record year for company registrations in Harrow when compared to any year in history.

A total of 2,691 companies were formed in Harrow in 2011. This total is 2.3% higher than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Harrow when compared to any previous second half year.

#### new companies by half year






#### new companies by quarter



#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 957 companies were dissolved in Harrow. This figure is 1.2% higher than last year, which compares badly to the UK wide change of -7.5%.

#### dissolved companies by half year




A total of 475 companies were dissolved in Harrow during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 834 companies were added to the company register for Harrow in 2011. This number represents growth of 31.7% which compares unfavourably to the UK figure of 34.6%.




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Harrow during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 177 companies.

This represents an increase of 30.1% on the same period last year.





#### company share by year




#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 40.3.

The percentage of directors over the age of 65 was 3.5% compared to the UK figure of 4.1%.


#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)
