- 2011 was a record year for net growth in Hassocks when compared to any year in history.



new companies by year




Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 76 companies were formed in Hassocks. This figure is 26.9% lower than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Hassocks occurred in 2010 when a total of 104 were formed.

new companies by half year




A total of 29 companies were registered in Hassocks during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 26 companies were dissolved in Hassocks during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter

2011 was a record year for net growth in Hassocks when compared to any year in history.


A total of 95 companies were added to the company register for Hassocks in 2011. This number represents growth of 50.0% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Hassocks during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 3 companies.








company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)
