

new companies by half year




# Quarterly Data (Q2 Apr-Jun 2011)



#### new companies by month





#### dissolved companies by half year






A total of 40 companies were dissolved in Hastings during the second quarter of 2011 (Apr 2011 - Jun 2011).

#### dissolved companies by quarter






Q2 2011 saw a new record in net growth in Hastings when compared to any previous Q2.




company share by half year





#### director age by half year



The percentage of directors over the age of 65 was 4.3% compared to the UK figure of 4.3%.




#### director age by quarter

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2011)
