The first half of 2011 saw a new record in company registrations in Hayes when compared to any previous first half year.


The first half of 2011 was a record first half year for company registrations in Hayes when compared to any half year in history.

new companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





dissolved companies by half year





A total of 131 companies were dissolved in Hayes during the second quarter of 2011 (Apr 2011 - Jun 2011).





net growth by half year









company share by half year







director age by half year






director age by quarter

director gender by half year


