




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 181 companies were formed in Haywards Heath. This figure is 3.4% higher than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Haywards Heath occurred in 2006 when a total of 316 were formed.




#### new companies by half year





dissolved companies by year




## Half Year Data (Jul-Dec 2011)

#### dissolved companies by half year




A total of 75 companies were dissolved in Haywards Heath during the fourth quarter of 2011 (Oct 2011 - Dec 2011).








## Half Year Data (Jul-Dec 2011)




Net company growth for Haywards Heath during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 17 companies.

#### net growth by quarter













#### director age by year




#### director age by half year

#### director age by quarter





#### director gender by year




# Half Year Data (Jul-Dec 2011)
