

A total of 103 companies were formed in Hebden Bridge in 2011. This total is 14.4% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Hebden Bridge when compared to any previous second half year.


Q4 2011 saw a new record in company registrations in Hebden Bridge when compared to any previous Q4.






The second half of 2011 saw a new record in company closures in Hebden Bridge when compared to any previous second half year.


Q4 2011 saw a new record in company closures in Hebden Bridge when compared to any previous Q4.




A total of 58 companies were added to the company register for Hebden Bridge in 2011. This number represents growth of 64.4% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year







company share by half year





director age by year





director age by quarter





director gender by year




Half Year Data (Jul-Dec 2011)

39.0% of all director appointments in Hebden Bridge in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
