

A total of 111 companies were formed in Helston in 2011. This total is 6.7% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 56 companies were formed in Helston. This figure is 24.4% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Helston occurred in 2002 when a total of 62 were formed.




A total of 27 companies were registered in Helston during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

## dissolved companies by half year




A total of 24 companies were dissolved in Helston during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

#### dissolved companies by quarter




A total of 29 companies were added to the company register for Helston in 2011. This number represents growth of 27.9% which compares unfavourably to the UK figure of 34.6%.




#### Half Year Data (Jul-Dec 2011)




Net company growth for Helston during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 3 companies.

This represents a decrease of 66.7% on the same period last year.








#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 47.6.
