The first half of 2011 saw a new record in company registrations in Hemel Hempstead when compared to any previous first half year.


The first half of 2011 was a record first half year for company registrations in Hemel Hempstead when compared to any half year in history.

In the first half of 2011 a total of 467 companies were formed in Hemel Hempstead. This figure is 15.3% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Hemel Hempstead occurred in 2011 when a total of 467 were formed.

#### new companies by half year




# Quarterly Data (Q2 Apr-Jun 2011)

Q2 2011 saw a new record in company registrations in Hemel Hempstead when compared to any previous Q2.

A total of 234 companies were registered in Hemel Hempstead during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is an increase of 23.2% versus the same period last year (Q2 2010). This figure compares well to the UK as a whole, which saw an increase of 13.9% against the same period last year.






## Quarterly Data (Q2 Apr-Jun 2011)

A total of 104 companies were dissolved in Hemel Hempstead during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is a decrease of 20.6% versus the same period last year (Q2 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 24.9% against the same period last year.



#### net growth by half year




## Quarterly Data (Q2 Apr-Jun 2011)




company share by half year





#### director age by half year




## Quarterly Data (Q2 Apr-Jun 2011)

The percentage of directors over the age of 65 was 1.7% compared to the UK figure of 4.3%.






The record first half year for female directors in Hemel Hempstead was 1861 when 40.0% of all directors were female.

#### director gender by half year




## Quarterly Data (Q2 Apr-Jun 2011)

The record second quarter for female directors in Hemel Hempstead was in 1866 when 66.7% of all directors were female.
