

A total of 881 companies were formed in Hemel Hempstead in 2011. This total is 13.7% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Hemel Hempstead when compared to any previous second half year.


Q4 2011 saw a new record in company registrations in Hemel Hempstead when compared to any previous Q4.





dissolved companies by year




Half Year Data (Jul-Dec 2011)




A total of 111 companies were dissolved in Hemel Hempstead during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Hemel Hempstead during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 88 companies.








company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)
