


Quarterly Data (Q2 Apr-Jun 2011)





A total of 26 companies were dissolved in Hoddesdon during the second quarter of 2011 (Apr 2011 - Jun 2011).





net growth by half year













director age by half year






director age by quarter

director gender by half year


