






A total of 35 companies were dissolved in Holmfirth during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 60 companies were added to the company register for Holmfirth in 2011. This number represents growth of 41.1% which compares favourably to the UK figure of 34.6%.




Half Year Data (Jul-Dec 2011)



net growth by quarter






company share by year







director age by year





director gender by year




Half Year Data (Jul-Dec 2011)
