

A total of 1,700 companies were formed in Hove in 2011. This total is 16.3% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Hove when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Hove when compared to any previous Q4.





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 186 companies were dissolved in Hove during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 986 companies were added to the company register for Hove in 2011. This number represents growth of 67.4% which compares favourably to the UK figure of 34.6%.

net growth by year





net growth by half year



net growth by quarter



net growth by month



company share by year




company share by half year





director age by year





director age by half year




director age by quarter

director gender by half year


