In the first half of 2011 a total of 592 companies were formed in Huddersfield. This figure is 8.2% higher than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Huddersfield occurred in 2011 when a total of 592 were formed.


Q2 2011 saw a new record in company registrations in Huddersfield when compared to any previous Q2.





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)






company share by half year





director age by half year



The percentage of directors over the age of 65 was 2.5% compared to the UK figure of 4.3%.




director age by quarter

director gender by half year




Quarterly Data (Q2 Apr-Jun 2011)
