The first half of 2012 saw a new record in company registrations in Huddersfield when compared to any previous first half year.


The first half of 2012 was a record first half year for company registrations in Huddersfield when compared to any half year in history.

In the first half of 2012 a total of 659 companies were formed in Huddersfield. This figure is 11.3% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Huddersfield occurred in 2012 when a total of 659 were formed.

#### new companies by half year




## Quarterly Data (Q2 Apr-Jun 2012)

Q2 2012 saw a new record in company registrations in Huddersfield when compared to any previous Q2.

A total of 303 companies were registered in Huddersfield during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 10.6% versus the same period last year (Q2 2011). This figure compares equally to the UK as a whole, which saw an increase of 8.3% against the same period last year.





## Quarterly Data (Q2 Apr-Jun 2012)

A total of 165 companies were dissolved in Huddersfield during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is a decrease of 8.8% versus the same period last year (Q2 2011). This figure compares well to the UK as a whole, which saw an increase of 12.5% against the same period last year.




Q2 2012 saw a new record in net growth in Huddersfield when compared to any previous Q2.

This represents an increase of 48.4% on the same period last year.






company share by half year





#### director age by half year




#### Quarterly Data (Q2 Apr-Jun 2012)

The percentage of directors over the age of 65 was 0.8% compared to the UK figure of 3.3%.




#### director age by quarter

24.9% of all director appointments in Huddersfield in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

#### director gender by half year




## Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Huddersfield was in 1866 when 66.7% of all directors were female.

26.7% of all director appointments in Huddersfield in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
