


Half Year Data (Jul-Dec 2011)

new companies by half year




A total of 254 companies were registered in Hull during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 245 companies were dissolved in Hull during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of 147 companies were added to the company register for Hull in 2011. This number represents growth of 13.7% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Hull during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 9 companies.





company share by year




company share by half year





director age by year





director age by half year




director age by quarter
