

## Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Hungerford when compared to any previous second half year.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Hungerford when compared to any previous Q4.





dissolved companies by year




# Half Year Data (Jul-Dec 2011)

## dissolved companies by half year




A total of 17 companies were dissolved in Hungerford during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 58 companies were added to the company register for Hungerford in 2011. This number represents growth of 55.2% which compares favourably to the UK figure of 34.6%.

#### net growth by year




## Half Year Data (Jul-Dec 2011)

#### net growth by half year




Q4 2011 saw a new record in net growth in Hungerford when compared to any previous Q4.

This represents an increase of 175.0% on the same period last year.






company share by year




company share by half year





#### director age by year





#### director age by quarter





#### director gender by year




# Half Year Data (Jul-Dec 2011)

35.2% of all director appointments in Hungerford in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


#### director gender by half year
