




## Quarterly Data (Q2 Apr-Jun 2011)



#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)

A total of 68 companies were dissolved in Huntingdon during the second quarter of 2011 (Apr 2011 - Jun 2011).












company share by half year





The percentage of directors over the age of 65 was 6.7% compared to the UK figure of 4.3%.


#### director age by quarter

The record second quarter for female directors in Huntingdon was in 1866 when 66.7% of all directors were female.

33.3% of all director appointments in Huntingdon in the second quarter of 2011 were female. This compares to a UK average of 26.1% for the same period.
