

#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 76 companies were formed in Ilkeston. This figure is 35.7% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Ilkeston occurred in 2003 when a total of 91 were formed.

#### new companies by half year




A total of 39 companies were registered in Ilkeston during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### new companies by quarter



#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

## dissolved companies by half year




A total of 23 companies were dissolved in Ilkeston during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 63 companies were added to the company register for Ilkeston in 2011. This number represents growth of 47.4% which compares favourably to the UK figure of 34.6%.




#### Half Year Data (Jul-Dec 2011)




Net company growth for Ilkeston during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 16 companies.


#### net growth by quarter






#### company share by half year





#### director age by year





#### director age by half year



#### director gender by year




## Half Year Data (Jul-Dec 2011)

#### director gender by half year


