The first half of 2011 saw a new record in company registrations in Ipswich when compared to any previous first half year.


The first half of 2011 was a record first half year for company registrations in Ipswich when compared to any half year in history.

In the first half of 2011 a total of 590 companies were formed in Ipswich. This figure is 6.9% higher than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Ipswich occurred in 2011 when a total of 590 were formed.

new companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





dissolved companies by half year





A total of 199 companies were dissolved in Ipswich during the second quarter of 2011 (Apr 2011 - Jun 2011).





net growth by half year





Net company growth for Ipswich during the second quarter of 2011 (Apr 2011 - Jun 2011) was 83 companies.





company share by half year







director age by half year




